

## Information and conditions of use concerning the exercise of the right of withdrawal

### Right of withdrawal

You have a right of withdrawal of 14 days from the day after you—or a third party designated by you, other than the carrier—take physical possession of the ordered item. (In the case of an order for multiple items delivered separately, this right begins upon physical possession of the last item).

To exercise your right of withdrawal, you must notify us of your decision to withdraw in writing (without needing to provide a reason) before the deadline expires. This notification must be sent by post or email to the following addresses:

To do so, you may use the attached withdrawal form, duly completed, although this is not mandatory. If you send us your request in a free-form letter or email, please include the following information to ensure efficient processing: the date of the request, your full contact details, your order number and order date, the reference number(s) of the item(s) being returned, and the date you received the product. If submitting a paper request by post, please do not forget to sign it.

### Withdrawal effects

In the event of withdrawal on your part, we undertake to refund the payment(s) received for the returned product(s), including delivery costs (with the exception of additional costs arising from your choice, where applicable, of a delivery method other than the least expensive standard delivery offered by us); without undue delay and no later than 14 days from the day on which we are informed of your decision to withdraw. The refund will be made using the same means of payment as you used for the initial transaction, unless you expressly request a different means (orders paid for by credit note or gift voucher can only be refunded by credit note or gift voucher); in any event, this refund will not incur any costs for you.

The refund may be deferred until we have received the returned goods or provided proof of shipment of the goods, whichever is earlier.

### **\*You are responsible for the direct costs of returning the goods.\***

Products that you have requested to be engraved are personalised and cannot be resold. Therefore, these products cannot be returned under the right of withdrawal. Similarly, the product must be returned to us in its original condition, i.e. new, complete and free from any signs of use other than those necessary to establish its nature, characteristics and proper functioning. Items that have been worn excessively (trying on the product is tolerated, in the same way as when purchasing in a physical store), damaged, soiled or incomplete will not be accepted for return. Please take care when packaging and protecting the product(s) to ensure the best possible transport conditions.
